Dear Parent, Guardian and School Staff:

The Guilderland Central School District is required by the Neighbor Notification Law, Laws of New York, 2000, Chapter 285, section 409-h to advise stakeholders of the following points: Pesticide products may be used periodically throughout the school year; name of school representative(s) to contact for further information (see below): And, that "Schools are required to maintain a list of staff and persons in a parental relation who wish to receive forty-eight hour prior written notification of pesticide applications at relevant facilities". To register, and be on the Guilderland Central School District list, please fill out the information below, and return to the Principal's office. **Please note that this form is not required to be returned if you do not wish to be placed on the register.** For any additional information regarding registration, please contact Clifford Nooney, Supervisor of Buildings and Grounds, at (518) 861-5246. Only one application form per family per school year is necessary.

as put forth in section 409-h of the Education Law, 48 hours prior to any pesticide application. In the event an emergency application is necessary to protect against an imminent threat to human health, a good faith effort will be made to supply written notification to those on the 48 hour prior notification list. The following pesticide applications are not subject to prior notification requirements:

- A school remains unoccupied for a continuous 72 hours following an application;
- Anti-microbial products;
- Nonvolatile rodenticides in tamper resistant bait stations in areas inaccessible to children;
- Nonvolatile insecticidal baits in tamper resistant bait stations in areas inaccessible to children;
- Boric acid and disodium octoborate tetrahydrate;
- The application of EPA designated biopesticides;
- The application of EPA designated exempt materials under 40CFR152.25;
- The use of aerosol products with a directed spray in containers of 18 fluid ounces or less when used to protect individuals from an imminent threat from stinging and biting insects including venomous spiders, bees, wasps and hornets.
