 - Incomplete applications, or applications with information that does not match the SIS, cannot be accepted and will be returned within 5 business days to the parent/guardian's email address that is on the student's GCSD registration.
 - **APPLICATIONS RECEIVED AFTER THE APRIL 1 DEADLINE:** Transportation will only be provided if space is available on an already scheduled bus to the school being requested. No applications will be considered if a bus is not already transporting students to that school. Late applications will experience a delay in processing.
